



## DISNEY GRAD NIGHT



### Parents/Guardians and Seniors---- Class of 2020

Mission Hills High School Parent Association (MHPA) is preparing to celebrate the Senior Class of 2020 at **Disneyland Resort Grad Nite on Friday, June 12, 2020, - two days after graduation.**

MHPA will soon begin to sell reservations for Grad Nite 2020. The ticket for Grad Nite includes a Disney Park Hopper Ticket with access to both parks for the day, entry to the exclusive Grad Nite Party at Disney California Adventure from 9:30pm to 2am, and (mandatory) bus-ride transportation on SMUSD buses to and from Anaheim.

#### **TICKET SALES SCHEDULE: (in front of the ASB room)**

**Cost: \$195 -CASH/CHECK**

**\$200-DEBIT/CREDIT CARD**

**Tuesdays (Before school 8am -8:40am): 2/25, 3/3\*, 3/10, 3/17, and 3/24**

(\*3/3 sales from 7am to 7:45am- on Shadow-a-Grizzly and for 30 minutes after Shadow a Grizzly)

**Fridays (at lunch): 2/28, 3/6, 3/13, 3/20 and 3/27**

**ALL STUDENTS must have the 2020 Grad Nite Permission Agreement AND the Disneyland Resort Parental Consent Form** signed by a parent/legal guardian along with payment at the time of the sale. Students should bring these completed forms, student Id, and payment to the Grad Nite Table in front of the ASB room on designated ticket sales days.

*Please make checks payable to GBEF/MHPA (include student last name and id# on memo line- if paying by cash, please have exact change, as we may not be able to break larger bills)*

**Buy your tickets early as we have a limited amount available!**

#### **TICKETS ARE NON-TRANSFERABLE AND NO REFUNDS AFTER MARCH 27, 2020**

Bus assignments are typically based on when reservations are received. If you want to ride with friends, try to buy your tickets at the same time. You may request one friend to ride (See: Section 4 of the Permission Agreement) BUT the friend must also request you in return. Participants will not be allowed to switch buses at any point during the trip. (Note: Students are not allowed to drive themselves to/from Disneyland Resort, they are required to ride on the buses for this event. Annual Disney passes may not be used for entry into Grad Nite)

**Grad Nite:** Friday, June 12, 2020- two days after graduation

**Check-in:** 8am in the MHHS parking lot/gym

**Depart-** buses will promptly depart at 9am. Be on time. *If you miss departure your ticket is forfeited.*

**Return-** buses arrive back at MHHS parking lot between 4:00-5:00 am, Saturday, June 13<sup>th</sup>.

**DISNEYLAND RESORT -PARENTAL CONSENT FORM**

**THIS FORM MUST BE completed by PARENTS OF ALL STUDENTS attending Grad Nite 2020**

My son/daughter (listed below) will be attending Grad Nite at the Disneyland Resort. I understand that certain rules and regulations will be in effect during Grad Nite, as those listed below, and I agree to advise my child of such rules and regulations prior to Grad Nite. I also acknowledge and agree that in the event my son/daughter violates any of such rules and regulations, he/she will be required to exit the Disneyland Resort and in such event, I agree to be responsible for picking up my child at the Disneyland Resort.

The following items are prohibited (All students bags will be searched and students will pass through metal detectors prior to entering Disneyland Resort; also present Anaheim police with a canine unit).

- Alcoholic beverages and any illegal narcotics/substances.
- Marijuana (or any of its derivatives including marijuana enriched products), even if it has been legally prescribed to the student or chaperone.
- Self-defense or restraining devices (e.g., pepper spray, mace).
- Glass containers of any size or type including perfume/cologne bottles, make up bottles and reusable water bottles.
- All outside food and liquids including factory-sealed water bottles.
- Firearms, ammunition or weapons of any kind, or objects or toys that appear to be firearms or weapons.
- Fireworks or other similarly explosive and/or flammable objects.
- Laser pointers or other items deemed potentially harmful or disruptive including Bluetooth speakers.
- Smoking, vaping device(s), electronic cigarette, wax pens.
- Selfie sticks and hand-held extension poles for cameras and mobile devices.
- Suitcases, bags, coolers or backpacks, with or without wheels, that are larger than 24” long x 15” wide x 18” high.
- Musical instruments.
- Large tripods or monopod stands and professional photography equipment and lighting.
- Recreational devices such as drones, remote control toys, skateboards, scooters, inline skates and shoes with built-in wheels.

I also expressly consent that my son/daughter may be subject of a pat down search by Disney while on the premises of the Disneyland Resort.
